COMMUNITY WORKFORCE PARTNERSHIP (CWP)



Sector intermediaries need to organize and align community infrastructure to ensure people have access and better preparation for industry - especially for skilled and technical occupations

WHY?

COMMUNITY WORKFORCE PARTNERSHIP WHAT IS IT?

- A formal network of community based organizations that provide specialized services often needed to address barriers to employment including lack of transportation, childcare, education, employability skills, ex-offender re-entry, and low income support
- Identifies the community resources available to clients and connects them to the ecosystem of accesses to those services
- Helps secure employment for these individuals + aids them in becoming more stable and prepared to meet the employer's work environment requirements.

COMMUNITY WORKFORCE PARTNERSHIP (CWP)

- This referral process happens through the intake and case management service providers at one agency being aware of the myriad of services offered by the other agencies in the partnership (*Training*, *Employment*, *Barrier Remediation*, *Supportive Services*, *Etc.*)
- By aligning the needs of the industry and resources of the community, the CWP connects employers to the vast network of Un and Under employed individuals.
- Helps adults and in some case's youth, looking for family supporting careers.
- Has been successful in reducing the turnover rates of these employees as well as increasing overall productivity.

COMMUNITY WORKFORCE PARTNERSHIP (CWP) HOW IT WORKS

The CWP meets regularly to coordinate referrals, delivery of services methods, outreach activities, field work, and the management of data with a goal to serve the whole needs of participants while minimizing the duplication of services.

Current work includes:

- Initiating partnerships and fostering a robust referral system.
- Creating a deliberate and consistent process for participant entry, case management, data collection and reporting.
- Continuing to identify areas that can build the capacities and strengths of participating agencies.

HOW IT WORKS

Initiating partnerships and fostering a robust referral system.

- The (MOU) Memorandum Of Understanding codifies the partnership between the convener and the participating organization
 - Helps to set forth the terms and expectations related to the partnership
 - No cost agreement
 - Clearly identifies the intended role that each organization will play and the key staff who will be assigned.
- Use of a common referral form
 - Agreed upon basic set of enrollment requirements
 - Derived from industry-informed sector specific parameters
 - Helps each participating organization to uniformly identify who they should be considering as a good candidate for referral.
- Single point of contact for referral's and data collection
 - Deliberate and consistent process for participant entry ,case management, data collection and reporting.
- Continuing to identify areas that can build the capacities and strengths of participating agencies.

HOW IT WORKS

<u>Continuing to ID areas that can build the capacities and</u> <u>strengths of participating agencies and the partnership.</u>

- Educating and informing the partners on what programs and services each organization offers
 - informs the collective
 - Partner updates at monthly meetings
 - CWP informational handbook or Newsletter.
- Identifying partner similarities in programming and the populations each serves helps to reduce the duplication of services.
- The thoughtful alignment of CWP partner strengths and weaknesses
 - Allows for greater collaboration between entities
 - Generates opportunities for new innovative ways for groups to leverage funding
 - Creates joint funded programs and demonstrates strong interagency partnerships that work.

HOW IT WORKS

Examples of Partnership Outcomes

The Literacy Services of Wisconsin /WRTP-BIG STEP 509 MC3-HSED program Students learn construction skills and earn valuable industry recognized certifications by completing the North American Building Trade Unions Multi Core Craft Curriculum (MC3) while simultaneously earning their High School Equivalency Diploma (HSED)

The Legal Action of Wisconsin Drivers Recovery program.

links participants to Legal Action of Wisconsin's Road to Opportunity program. This project focuses on wide range of barriers: Inaccurate or misleading criminal records or arrest records; Denials or revocations of occupational licenses; Driver's license revocations and suspensions; Excessive child support arrears; Evictions or foreclosures.

Educating and informing the partners on what programs and services each organization offers informs the collective.

The Handbook was created in direct response to the reoccurring theme around the table of organizations not really knowing what each other had to offer. This was one a first steps too identifying areas and opportunities for collaboration.


